Dr. Kathryn J Draeger

Kathryn Draeger is Statewide Director for the U of M Regional Sustainable Development Partnerships and adjunct professor of Agronomy and Plant Genetics. She oversees statewide programming in sustainable development, including clean energy and sustainable ag and food systems. Dr. Draeger is currently principle investigator on USDA-AFRI-NIFA grant to develop innovative supply chains for locally produced food as well as other sustainable ag related efforts. She has been a Bush Leadership Fellowship and a MacArthur Scholar. She served as an Environmental Protection Commissioner in Iowa and was appointed to the Governor's Roundtable for Sustainable Development in Minnesota. Before joining the U she founded two successful corporations Sustainability International, Inc. and Environmental Ground, Inc. In 2007, Kathy and her family moved to rural Big Stone County MN to live and farm sustainably. Kathy holds a doctorate in water resources and master's in Soil Science from the University of Minnesota.

Paul Gardner is the Chair of the Recycling Association of Minnesota and Administrator of the Minnesota Clean Water Council. He has two decades of experience at different roles in recycling both in Minnesota and nationally. Gardner was a state legislator in Minnesota from 2007 and 2010, and headed up a nonprofit working with a large consumer brand from 2011 to 2015 that advocated for extended producer responsibility (EPR) for packaging in the United States.

Jim Schuld is a seasoned supply chain and operations executive with over 21 years of experience in the medical device industry. Currently, he holds the position of Director — Technology & Innovation Strategy at Medtronic, where he is responsible for developing and implementing the company's global supply management innovation strategy. Throughout his career at Medtronic, Mr. Schuld has consistently demonstrated leadership in driving operational excellence, product innovation, and sustainability. Notably, he led teams to achieve a prestigious Global Medtronic Sustainability Award in 2020 for their work in implementing circular and reverse supply chains. He is a recipient of multiple Medtronic Star of Excellence awards, recognizing his contributions to the company's success.

For Courtney Panther, it's always about the people, and it's this approach that allowed her to impact organizational change, specifically in terms of sustainability, at Sleep Number. With a background in people leadership and a degree in chemical engineering, Courtney joined the Sleep Number team as the Senior Production Manager, a role which involved starting and managing the company's DFW Assembly and Distribution Center. In April 2023, her role changed to become the Material Recovery Manager, a new position designed to recover returned products so they can be properly refurbished and used to satisfy warranty claims.

"This initiative drives towards the goal of improving material circularity and pioneering sustainability. Due to her strong leadership skills, she has been able to drive cross functional organizational change at a level that is very uncommon at Sleep Number. Courtney is leading the way in extending the useful life of Sleep Number's products while also increasing gross margins."
